The Renewable Heat Incentive



A **Green Deal Assessment** is required to access incentive payments for customers installing:

- Ground and air source **heat pumps**
- **Biomass** boilers and biomass pellet stoves with integrated boilers
- **Solar** thermal panels

If you are a renewable heating installer why not get in touch with people who have installed these technologies since July 2009 to let them know about the introduction of the incentive, and how they can apply? We can work with you to pass on details to these customers.

Eligibility for the higher rate **domestic feed in tariff** requires an **Energy Performance Certificate** rating of 'D' or above. We can provide people with an EPC, and the advice they may require to help them achieve a 'D' rating. (Basic property floor plans are also available by prior arrangement). We can provide an EPC at the following rates:

- For properties up to 5 bedrooms – £60 (+VAT)
- For properties of 6 bedrooms or above – £70 (+VAT)

If you are a Green Deal Accredited Installer and have customers interested in Green Deal finance, the **Green Deal Home Improvement fund**, or Energy Company Obligation (ECO) funding we can offer:

- **Free registration** with a Green Deal Provider who can help you and your customer gain access to Green Deal finance, ECO and other Green Deal incentives
- **ECO reports** if you are looking to access your own ECO funding
- **Information and advice** on how to become a Green Deal Accredited Installer if you are not currently involved in the scheme

Impartial assessments are offered at the following rates and are carried out by Severn Wye assessors or approved associates. These can be invoiced to your company or to the customer depending on your preference.

- For properties up to 3 bedrooms – £150 (+VAT)
- For properties of 4-5 bedrooms – £165 (+VAT)
- For properties of 6 bedrooms or above – Price on application

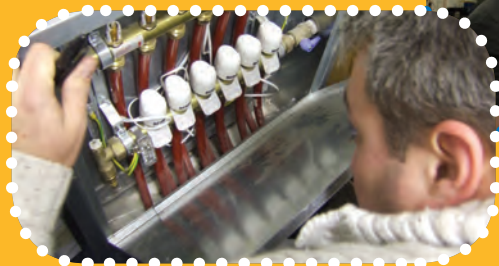
